4. processing purposes and legal basis

Your data is processed to the extent necessary for supplier and delivery ramp management. The processing is based on the legitimate interest, according to Art. 6 para. 1 lit.(f) GDPR. The interest here is efficient supplier management and time management.

5. data categories and data origin

We only transfer your personal data within our company to the departments and persons who need this data to process the shipment. Data is passed on to our data processor, LOGSOL GmbH & Co. KG, the provider of the RampMan system.

6. recipient and third country transfer

Within our company, we will only transfer your personal data to departments and persons who need this data to implement the measure. There is no transfer to third parties

7. your rights

When processing your data, you are entitled to the following rights according to Art. 15 to 22 GDPR:

- Right to information
- Right to rectification
- Deletion

- Restriction of processing
- Data portability

Insofar as the processing of your personal data pursuant to Art. 6 para. 1 lit.(a) is carried out on the basis of your consent or (f) GDPR to safeguard legitimate interests, you have the right under Art. 21 GDPR to object to the processing of such data at any time without needing a reason. We will then no longer process this personal data unless we can prove compelling reasons worthy of protection to continue processing. These must outweigh your interests, rights and freedoms, or the processing must serve to assert, exercise or defend legal claims.
